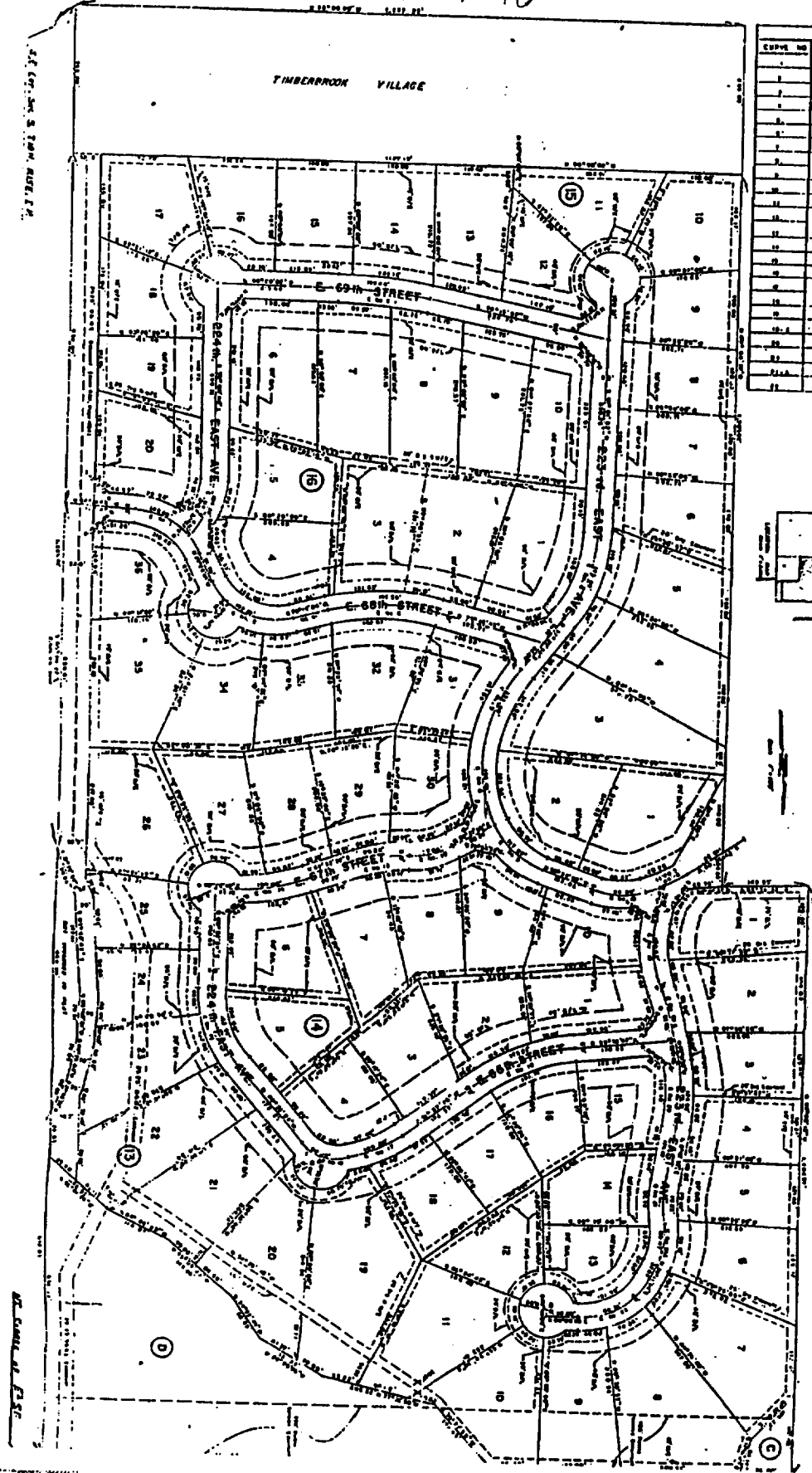
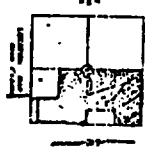

TIMBERBROOK IV, A SUBDIVISION OF A PART OF THE EAST HALF (E1/2)
OF THE SOUTHEAST QUARTER (SE 1/4) OF SECTION 5, TOWNSHIP 18 NORTH,
RANGE 15 EAST OF THE INDIAN BASE AND MERIDIAN

WHEREAS STATE FINANCIAL SERVICE CORPORATION, AN OKLAHOMA
CORPORATION, IS THE OWNER OF THE FOLLOWING DESCRIBED LAND IN THE
COUNTY OF WAGONER, STATE OF OKLAHOMA, TO-WIT:

THENCE: N 00° 08' 12" W, AND PARALLEL WITH THE WEST LINE OF SAID
EAST 1/2 SE 1/4, A DISTANCE OF 1283.96',
THENCE: N 89° 58' 02" W, A DISTANCE OF 145.00' TO A POINT ON THE
WEST LINE OF SAID E 1/2 SE 1/4, SAID POINT ALSO BEING ON
THE EAST LINE OF TIMBERBROOK SECTION 1,
THENCE: N 00° 08' 12" W, ALONG SAID WEST LINE E 1/2 SE 1/4, AND
ALONG THE EAST LINE OF TIMBERBROOK SECTION 1, A DISTANCE
OF 1084.57 TO A POINT ON THE NORTH LINE OF SAID E 1/2 SE 1/4,
THENCE: S 89° 42' 25" E, ALONG THE NORTH LINE OF SAID E 1/2 SE 1/4,
A DISTANCE OF 1321.36,
THENCE: S 00° 00' 22" E, ALONG THE EAST LINE OF SAID SE 1/4, A
DISTANCE OF 612.85',
THENCE: S 21° 43' 58" W, A DISTANCE OF 68.90',
THENCE: S 09° 35' 00" W, A DISTANCE OF 78.09',
THENCE: S 05° 07' 41" W, A DISTANCE OF 78.31',

THENCE: S 03° 52'43" E, A DISTANCE OF 177.41',
 THENCE: S 21° 35'38" E, A DISTANCE OF 94.64', TO A POINT ON THE
 EAST LINE OF SAID SE 1/4,
 THENCE: S 00° 09' 22" E, ALONG SAID EAST LINE SE 1/4, A DISTANCE
 OF 1265.01', TO THE POINT OR PLACE OF BEGINNING.

THE SAID DESCRIBED TRACT CONTAINS 67.14 ACRES MORE OR LESS AND IS
 SUBJECT TO EASEMENT AND RIGHTS OF WAYS OF RECORD.

WHEREAS: STATE FINANCIAL SERVICE CORPORATION, AN OKLAHOMA CORPORATION,
 HAS CAUSED THE ABOVE DESCRIBED LAND TO BE SURVEYED, STAKED, PLATTED
 AND SUBDIVIDED INTO LOTS, BLOCKS AND STREETS, AND HAS DESIGNATED
 THE SAME AS TIMBERBROOK IV, A SUBDIVISION OF A PART OF THE EAST HALF
 OF THE SOUTHEAST QUARTER (SE 1/4), SECTION 5, TOWNSHIP 18 NORTH,
 RANGE 15 EAST OF THE INDIAN BASE AND MERIDIAN, WAGONER COUNTY, OKLAHOMA.

NOW THEREFORE, FOR THE PURPOSE OF PROVIDING AN ORDERLY DEVELOP-
 MENT OF THE ABOVE DESCRIBED REAL ESTATE AND IN ORDER TO PROVIDE
 ADEQUATE COVENANTS, CONDITIONS AND RESTRICTIONS FOR THE MUTUAL
 BENEFIT OF SAID STATE FINANCIAL SERVICE CORPORATION AND ITS SUCCESSORS
 IN TITLE TO THE SUBDIVISIONS OF SAID LAND (HEREAFTER REFERRED TO AS
 LOTS), STATE FINANCIAL SERVICE CORPORATION HEREBY IMPOSES THE
 FOLLOWING EASEMENTS, COVENANTS, RESTRICTIONS AND CONDITIONS WHICH
 SHALL RUN WITH THE REAL PROPERTY AND SHALL BE BINDING ON ALL PARTIES
 HAVING OR ACQUIRING ANY RIGHT, TITLE OR INTEREST IN THE ABOVE
 DESCRIBED PROPERTY OR ANY PART THEREOF, AND SHALL INURE TO THE
 BENEFIT OF EACH OWNER THEREOF.

EASEMENTS AND RIGHTS OF WAY

- A. STATE FINANCIAL SERVICE CORPORATION DOES HEREBY DEDICATE FOR
 PUBLIC USE ALL OF THE STREETS AND UTILITY EASEMENTS AS SHOWN
 ON SAID PLAT AND DOES HEREBY GUARANTEE THE TITLE TO ALL OF THE
 LAND COVERED BY SAID STREETS.
- B. STATE FINANCIAL SERVICE CORPORATION FURTHER DEDICATES TO THE
 PUBLIC FOR PUBLIC USE FOREVER THE UTILITY EASEMENTS AND RIGHTS-
 OF-WAY AS SHOWN AND DESIGNATED ON THE PLAT FOR THE SEVERAL PURPOSES
 OF CONSTRUCTING, MAINTAINING, OPERATING, REPAIRING, REMOVING,
 REPLACING ANY AND ALL PUBLIC UTILITIES INCLUDING TELEPHONE LINES,
 ELECTRIC POWER LINES AND TRANSFORMERS, GAS LINES, AND WATER LINES,
 TOGETHER WITH ALL FITTINGS AND EQUIPMENT FOR EACH OF SUCH
 FACILITIES AND ANY OTHER APPURTENANCES THERETO WITH THE RIGHTS OF
 INGRESS AND EGRESS UPON SAID UTILITY EASEMENTS AND RIGHTS-OF-WAY
 FOR THE USES AND PURPOSES AFORESAID, TOGETHER WITH SIMILAR RIGHTS
 IN EACH AND ALL OF THE STREETS SHOWN ON SAID PLAT: PROVIDED,
 HOWEVER, THAT STATE FINANCIAL SERVICE CORPORATION, AN OKLAHOMA
 CORPORATION, HEREBY RESERVES THE RIGHT TO CONSTRUCT, MAINTAIN,
 OPERATE, LAY AND RELAY WATER LINES AND SEWER LINES TOGETHER WITH

THE RIGHT OF INGRESS AND EGRESS FOR SUCH CONSTRUCTION, MAINTENANCE OPERATION, LAY AND RELAYING OVER, ACROSS AND ALONG ALL OF THE PUBLIC STREETS, ALLEYS, AND UTILITY EASEMENTS, SHOWN IN SAID PLAT, AND/OR SEWER SERVICES TO THE AREA INCLUDED IN SAID PLAT AND TO ANY OTHER AREAS.

C. STATE FINANCIAL SERVICE CORPORATION AND ITS SUCCESSORS, FURTHER COVENANT THAT:

1. OVERHEAD POLE LINES FOR THE SUPPLY OF ELECTRIC AND TELEPHONE SERVICE MAY BE LOCATED AS SHOWN ON THE ATTACHED PLAT. STREET LIGHT POLES OR STANDARDS MAY BE SERVED BY UNDERGROUND CABLE AND ELSEWHERE THROUGHOUT SAID ADDITION ALL SUPPLY LINES, EXCEPT THOSE APPROVED BY THE ARCHITECTURAL COMMITTEE, SHALL BE LOCATED UNDERGROUND, IN THE EASEMENTWAYS RESERVED FOR GENERAL UTILITY SERVICES AND STREETS, SHOWN ON THE ATTACHED PLAT. SERVICE PEDESTALS AND TRANSFORMERS, AS SOURCES OF SUPPLY AT SECONDARY VOLTAGES, MAY ALSO BE LOCATED IN THE EASEMENTWAYS.
2. UNDERGROUND SERVICE CABLES TO ALL HOUSES WHICH MAY BE LOCATED ON ALL LOTS IN SAID ADDITION MAY RUN FROM THE NEAREST SERVICE PEDESTAL OR TRANSFORMER TO THE POINT OF USAGE DETERMINED BY THE LOCATION AND CONSTRUCTION OF SUCH HOUSE AS MAY BE LOCATED UPON SAID LOT: PROVIDED THAT UPON THE INSTALLATION OF SUCH A SERVICE CABLE TO A PARTICULAR HOUSE, THE SUPPLIER OF ELECTRIC SERVICE SHALL THEREAFTER BE DEEMED TO HAVE A DEFINITE, PERMANENT AND EFFECTIVE RIGHT-OF-WAY EASEMENT ON SAID LOT, COVERING A FIVE FOOT (5') STRIP EXTENDING 2.5 FEET ON EACH SIDE OF SUCH SERVICE CABLE, EXTENDING FROM THE SERVICE PEDESTAL OR TRANSFORMER TO THE SERVICE ENTRANCE OF SAID HOUSE.
3. THE SUPPLIER OF ELECTRIC SERVICE, THROUGH ITS PROPER AGENTS SHALL AT ALL TIMES HAVE RIGHT OF ACCESS TO ALL SUCH EASEMENTWAYS SHOWN ON SAID PLAT, OR PROVIDED FOR IN THIS DEED OF DEDICATION FOR THE PURPOSE OF INSTALLING, MAINTAINING, REMOVING, OR REPLACING ANY PORTION OF SAID UNDERGROUND ELECTRICAL FACILITIES SO INSTALLED BY IT.
4. THE OWNER OF EACH LOT SHALL BE RESPONSIBLE FOR THE PROTECTION OF THE UNDERGROUND ELECTRICAL FACILITIES LOCATED ON HIS PROPERTY AND SHALL PREVENT THE ALTERATION OF GRADE OR ANY CONSTRUCTION ACTIVITY WHICH MAY INTEREFERE WITH SAID ELECTRICAL FACILITIES. REPAIRS OR COST OF RELOCATION, REQUIRED BY VIOLATION OF THIS COVENANT, SHALL BE PAID FOR BY THE OWNER OF THE LOTS.

THE PROVISIONS OF THESE DEDICATIONS MAY BE AMENDED, MODIFIED, CHANGED OR CANCELLED AT ANY TIME BY A WRITTEN INSTRUMENT SIGNED AND ACKNOWLEDGED BY STATE FINANCIAL SERVICE CORPORATION, ITS SUCCESSORS OR ASSIGNS, AND PROERLY RECORDED IN THE LAND RECORDS OF WAGONER COUNTY, OKLAHOMA. SUCH INSTRUMENT SHALL BE EFFECTIVE UPON THE DATE OF ITS RECORDING.

THAT SAID PROPERTY COVERED BY SAID PLAT AND DEDICATION IS SUBJECT TO CERTAIN RESTRICTIONS, RESERVATIONS AND COVENANTS CONTAINED IN A SEPARATE INSTRUMENT, WHICH SAID INSTRUMENT WILL BE DATED THE 13th DAY OF JANUARY, 1977 AND WHICH SAID INSTRUMENT CONSISTS OF FIVE (5) LEGAL SIZED SHEETS OF TYPEWRITTEN PAPER, WILL BE FILED OF RECORD IN THE OFFICE OF THE COUNTY CLERK OF WAGONER COUNTY, STATE OF OKLAHOMA, SUBSEQUENT TO AND AS A PART AND PARCEL OF SAID PLAT AND DEDICATION.

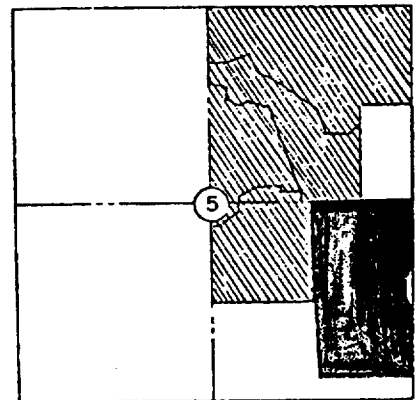
